The European Programs Office is part of "Petru Maior" University and is in charge with organizing and monitoring international projects and cooperation agreements, as well the information concerning the programs for education of the European Commission. The office organizes all the actions for international cooperation regarding the distribution of scholarships financed by the Romanian government, based on bilateral agreements and it monitors the participation of the university in all international programs. It is responsible for promoting the image of the university on an international level. The main objective is encouraging and extending the mobilities, focusing on their qualitative aspect: the mobility destinations that ensure the compatibility of study programs, the placements that ensure the accomplishment of the professional training, the teaching assignments and staff training mobilites that can be integrated in the usual program.

Upon returning to "Petru Maior" University, the student benefits of an automatic in integrum recognition of all credits obtained at the host university and of the study or placement period (according to the Learning Agreement and to the results written in the Transcript of Records). The certification of this transfer of credits is done by the authorized representative who signed the Learning Agreements, respectively the dean of the faculty where the student is matriculated. The entire period of study done at the host university replaces, by recognition, a period with the same duration and work volume (measured in ECTS, according to the Bologna system) that the students would otherwise make at the institution where they are matriculated.

At "Petru Maior" University, courses are taught in Romanian. The Philology Department has specific courses in English, French. The use of foreign languages of international circulation in the didactic process is strongly encouraged, and for incoming students, there are already some courses taught in English. Partners are chosen from the point of view of the compatibility of the study program, of the feasibility of the proposed exchanges, the technical and logistical arrangements, based on the experience gathered in the previous years. The activities from the bilateral agreements are the result of the cooperation initiatives of the professors at faculty level and are subject to negotiation between partners. The bilateral agreements are concluded at the level of faculties or departments, being then undertaken at the level of the central administration. Many of the cooperation agreements with European universities have been extended or renewed, thus putting to good use the contacts and the relations made by the professors and the students in different previous visits and mobilities. A permanent dialogue is kept with the institutions from the economic environment; thus, the cooperation with the industrial and business environment is more powerful and stable.

The higher education system from Romania, including the pre-university education, ensures the linguistic training of students for two languages of international circulation.

Selection of candidates is made based on their competences, including the linguistic ones, by a commission at the level of every faculty. Students are asked to provide a certificate of linguistic competences for the language of education at the host university or for a language of international circulation.

Ensure that student and staff mobility for education or training purposes is based on a learning agreement for students and a mobility agreement for staff validated in advance between the home and host institutions or enterprises and the mobile participants.

Incoming students are assigned an academic tutor (a professor), for the entire period of their stay at the university, who ensures the monitoring and the evaluation of their activity. For a best integration in the social and academic environment, they are also assigned a student tutor.Students having study mobilities or placements are assisted through monitoring activities by persons from the management of university or from the European Programs Office.These monitoring visits follow the specific activities and ensure that they are respected and put into practice.The academic staff is given the possibility to organize the didactic activity from their own university so that they may perform their mobilities in best period, agreed by partner.

The recognition procedure is settled by the Regulation for the Recognition Procedure of the Study and Placement Periods within Erasmus Mobilities. The Dean is the competent authority at the faculty regarding the Learning Agreements or the Training Agreements and the academic recognition. At the university level, the competent authority is the institutional coordinator. Upon returning, the student's credits from the host university will automatically be recognized and written in the Diploma Supplement, according to the Learning Agreement and the Transcript of Records. The certification of this transfer of credits is done by the authorized representative who signed the Learning Agreements, respectively the dean.

The legislation and the public policies in education support the Erasmus mobilities. Participation to international mobilities being a criterion in the evaluation and the professional promotion of the academic staff, the academic staff is more interested in participating in the program. The professors who have teaching assignments come back with a different mentality and other didactic methods, that they are encouraged to apply them in their daily didactic activity. An improvement of the curricula and of the teaching methods was seen, following the exchange of experience and good practices.

The development of the multicultural component of education is considered of high importance. The valorization of the former Erasmus students, their return to the academic activity, their integration in the labour market is also extremely important. They are involved in volunteer activities, especially for the benefit of the future Erasmus students or for the incoming students. All students who had an Erasmus mobility receive a diploma at the graduation festivity. The professors who have teaching mobilities are encouraged to apply the new teaching methods seen during their mobility, to improve the curriculum, to introduce new courses. Participation to international mobilities is a criterion in the evaluation and the professional promotion.

"Petru Maior" University of Targu Mures has taken the responsibility of being an active partner in the formation of the European Higher Education Area, having as a main aim of its development policy the modernization and internationalization of the higher education, trying, at the same time, to harmonize its own academic culture with the European one. Thus, the university signed the main document for European academic cooperation, Magna Charta Universitatum (Bologna, 2005), and is a member of the most important academic organizations: EAU, IAU, AUF, HUMANE, GUNI, EPUF. "Petru Maior" University of Targu Mures will continue to be an active partner in the academic activity of the organizations whose member it is, in order to be in synchrony with the trends of development of the international academic environment, participating at conferences and at their main activities. The university will develop its participation in the actions of the Program, trying to extend its cooperation with partners from both the EU and non-EU countries. A careful evaluation of the possible partners is done every time, from the point of view of the compatibility of the study program, the feasibility of the exchanges proposed, the technical and logistical arrangements, in order to ensure the objective for growth and relevance of the education quality. The Bilateral Agreements with the partners are signed at the level of faculties or departments, having in view the compatibility of the study programs, the placements that could complete the academic training, those teaching assignments and training programs for the academic and administrative staff that could be integrated, vastly, in the usual program of the partner universities. We will keep intensifying the dialogue with the enterprises and the organizations from both the national and international economic area, thus making the cooperation with the industrial and business environment stronger and more stable. The scope is to raise the students' interest and that of the economic organizations for placements, to create the best conditions for them, and to facilitate the insertion of the graduates on the labour market. The constant growth of the ERASMUS mobilities at the level of students (outgoing and incoming) and of the academic staff will be encouraged in the future as well, being supported by the competitive educational offer that the university has to define as a host institution. Mission indicators will be set so that "Petru Maior" University may transfer positive experiences from the partner universities. The staff training mobilities for the administrative staff will continue to be supported, given the necessity to raise the level of professionalism to European requirements. The participation to mobilities will be promoted and supported, as well as the academic exchanges and for curricular development, while looking for new opportunities for projects and programs. Partnerships with universities from the European and non-European areas will be initiated, in view of organizing joint programs (Joint Degrees) in English, for all levels of study. The extension of the cooperation relationships with universities and research institutes from abroad. through study programs, research, teaching assignments and students' mobilities will be a gualitative landmark for all the organization structures of our institution, for excellence and regional development. The use of foreign languages of international circulation in the didactic process of "Petru Maior" University is strongly supported and encouraged; there are already certain courses taught in English. In this context, the efforts for offering modules in foreign languages of international circulation, in our programs of study, will be continued, in order to facilitate the students' mobilities and that of the academic staff and, at the same time, to allow foreign students access to the courses offered by the university. Programs of study taught entirely in English, for both bachelor and master level, are undergoing the accreditation procedure. The academic staff from the university is allowed to organize its activity at the university so that the mobilities may be done in the best periods, previously agreed with the partners. Students with study mobilities and placements are assisted through monitoring activities at their host institutions by staff from the management of their faculties or from the European Programs Office. Foreign students coming to the university are ensured, through the care of the European Programs Office, an academic tutor in the person of a professor, for their entire period of stay at the university, who monitors and evaluates their activity. For the best integration of these students in the social and academic environment, a student tutor is also nominated for them, among the students who already have participated in the Erasmus Program. The incoming students benefit from an intensive Romanian Language course.

Original language [EN]

The university has implemented projects such as Do-IT, Done-IT, Global SRS, Move-IT, all being programs for the development of modern educational technologies, which include Blended Learning, Video-Conferences, Mobile Technologies. The university thus tries to make sure that it is compatible with the advances in educational standards from the other European countries and supports all its other projects in the same area.

Please explain the expected impact of your participation in the Programme on the modernisation of your institution (for each of the 5 priorities of the Modernisation Agenda*) in terms of the policy objectives you intend to achieve. (max. 3000 characters)

Original language [EN]

The participation in the Program will continue to support, through all the proposed actions of the Program, the modernization and internationalization of the university. The most important expected result is the growth and development of the international dimension, according to the objectives set, and the priorities of the Modernization Agenda, as follows: 1. New programs of study will be proposed or developed, having as language of teaching mainly languages of international circulation, at the level of European requirements. The university intends to develop international master and Joint Degree programs.

2. Development of international agreements based on compatibility and complementarity of study programs will ensure the accomplishment of the professional training.

Teaching programs of outgoing professors' mobilities will ensure their integration in the normal program of the partner university. Our programs are compatible with similar programs from our partner universities, having previously been benchmarked.

The University has received, following a national evaluation, the distinction "University with High Level of Trust" from the Romanian Association for Quality Assurance in Higher Education and is currently undergoing an EUA evaluation.

3. The university aims to extend its cooperation with countries from the EU, and also with third countries, having in view the organization of common projects such as Joint Degrees in English for all levels of education. Consequently, contacts of the students, of the academic and administrative staff made during the mobilities can ensure the internationalization of the university, as seen in the many partners of the university.

The university is expected to increase its participation in international programs, and to create a new network of partners among the third countries, in the view of developing TEMPUS programs.

4. Another important task is represented by the extension of the cooperation agreements with universities and research institutions, as well as with the business environment, through programs of study, research projects, students and professors mobilities. All research projects are immediately applicable in the industry; the university has over 40 patents that can be applied in industry.

5. "Petru Maior" University of Targu Mures is a true entrepreneurial university through the governmental resources, those attracted from the tuition fees, but also through the attraction of research contracts closed with local businesses, all due to the high level of commitment and involvement of the academic and research staff.
