Enrollment in higher education (bachelor, master, doctorate)

At "Petru Maior" University, courses are taught in Romanian.

When enrolling in degree programs taught in Romanian, the admission to the study programs is conditional upon acquiring the necessary knowledge of the Romanian language.

Preparatory year

Foreigners from non- EU are enrolled in higher education in Romanian after graduating from preparatory year in which acquire the requisite knowledge of language and specific knowledge in conjunction with the profile of future training (anatomy, physics, chemistry, drawing etc.).

Duration preparatory studies for undergraduate studies is one academic year and for master studies, doctoral and postgraduate residency is at least six months.

"Petru Maior" University is one of the accredited higher education institutions which organize preparatory course for learning Romanian (http://www.upm.ro/an_pregatitor/).

The categories of persons exempted from the obligation to present the certificate of completion of preparatory year, when enrolling in degree programs taught in Romanian

- People with Romanian educational documents (diplomas and certificates) or study documents certifying school situations at least four years of consecutive studies follow a national system of schools in Romania;
- Those who, in order to enter university teaching (except primary education), promoting the Romanian language test, an examination by a panel of head teacher / school and two teachers of Romanian language;
- Those who, in order to enter the university promotes Romanian language test, an examination by a special committee made up of teachers with at least the teaching lecturer. The examination can be done in the higher education institution at which the candidate wishes to study if the higher education institution pursuing a specialization / study program Romanian language and literature provisionally authorized or accredited or another higher education institution accredited performing such specialization / study program. This examination will be issued a certificate of proficiency.

Application Procedure

Candidates send the files **in two original copies** directly to the higher education institutions accredited or provisionally authorized their choice. Higher education institutions evaluating the dossiers according to regulations and communicate to the MEN the list of individuals selected letter of acceptance.

The documents must be legalized and apostilled copies with the Hague apostille.

MEN sends letters of acceptance from the institution of higher education and, where appropriate, diplomatic missions.

- Application form for issuing the Letter of Acceptance to study, completed in all rubrics -(download from the UPM or MEN website);
- CV of the applicant (mailing address, phone, email) and 2 recent photos of 3/4 format + Option for accommodation in the University premises;
- Study documents certified copy and translation (Baccalaureate Degree or its equivalent, Bachelor Degree Diploma and Master Degree Diploma, if applicable), legalized by the competent authorities of the issuing country;

- Transcripts of Study- certified copy and translation;
- Birth Certificate certified copy and translation;
- Preparatory year diploma or certificate of proficiency, as applicable;
- Copy of the passport valid at least 6 months after the date of issuance of the Letter of Acceptance to study certified copy and translation.
- Copy of the Identity Card, issued in the country of origin certified copy and translation.
- Medical certificate (in an international language) proving that the applicant does not suffer from contagious diseases or other illnesses incompatible with the future profession.
- Evidence of payment of the file processing fee.

The documents must be legalized and apostilled copies with the Hague apostille, translated in EN, FR or RO (authorized translations).

Fees

The minimum amount of tuition fees for foreigners from third countries is set out in Government Ordinance no. 22/2009 establishing minimum amount of tuition fees in foreign currency, studying on their own citizens in Romania from countries not members of the European Union and not part of the European Economic Area and the Confederation Swiss, approved with amendments by Law no. 1/2010.

- File processing fee (enrollment) for candidates outside EU: Bachelor, Master, Doctorate and postgraduate residency 250 euro;
- Annual fee for students outside EU: Bachelor, Master, Doctorate and postgraduate residency 2000 euro per year;
- Fee for additional year for students outside EU: Bachelor, Master, Doctorate and postgraduate residency 250 euro/for failed discipline and 250 euro to enroll in additional year;

Enrolment and submission of application files at UPM:

- June, 1st July, 15th registration and submission of files:
- July, 15th August, 25th the evaluation of the dossiers and sending to the Ministry of National Education (file copies + nominal table)
- September, 15th September, 30st files of accepted candidates sent to the Dean's office of the Faculty of Sciences and Letters and registration

Registration of candidates shall be made only after obtaining approval and letter of acceptance to studies issued by MEN, but not later than October, 31st.
