The participation of "Petru Maior" University of Targu Mures to the European Programs for higher education like TEMPUS, SOCRATES/ERASMUS, MINERVA, COMENIUS, GRUNDTVIG, LEONARDO DA VINCI, JEAN MONNET knew a significant growth every year, with positive results in education quality, as well as a relevant growth of the scientific research contracts. The actions for the implementation of the ECTS system, student moblities, teaching staff moblities, Curriculum Development projects ("EuPA-Education Europeene en Administration Publique", "MinSE-European Master in Heat Treatment and Surface Engineering"), individual scholarships for foreign language assistantship, summer courses, have all received funds. Preserving and developing the participation of the University to the actions of the Lifelong Learning Programs represents one of the major priorities of the University, based on its prior experience. Actions in progress at the present time will be continued, having in view the extension of the cooperation relations with universities and institutions of higher education abroad. We are encouraging and promoting participation to mobility programmes, academic exchanges and industrial placements, intensive programmes and curricular development. We are having in view obtaining funds for founding a Jean Monnet Chair. Erasmus Mundus projects will be created for sustaining financially international cooperation and stimulating international partners for some masters, thus answering an important part of the University's general strategy. The continuous development of national and international cooperation is achieved by: promoting the image and preoccupations of the "Petru Maior" University, by offering useful information in Romanian as well as English on the Erasmus actions and other LLP actions, and on the EPS in the first place; editing of presentation materials on the activities and specific regulations; meetings with students (especially of the 1st and 2nd years of study) for promoting such actions; presentation of material in the local media. Functioning in a multi-ethnic and multi-cultural geographical area, the University has an institutional culture resulted from its 45 years of existence, which assures a spirit of understanding and cohesion for persons belonging to different ethnies, religions and excludes manifestations contrary to the european and ecumenical spirit. Currently, persons with major physical disabilities can participate only to the activities of the University taking place in the building from the new campus (the Faculty of Economiv, Juridical and Administrative Sciences), built according to the new European regulations. Efforts are made to make the necessary improvements in the traditional buildings of the University, in the possible technical limits.

Quality of academic mobility activities:

What kind of specific measures are implemented in the institution to ensure high quality in academic mobility activities?

The University encourages students and teaching staff mobilities by supplying a financial support, from its own funds, both for the students and the teachers. The ECTS system was implemented in all level of studies, so students who participate at Erasmus mobilities benefite from complete academic recognition of all the activities provided in the partner-university. The adoption of the Diploma Supplement represents a very important instrument for increasing transparency in the process for the recognition of studies. By adopting specific measures (curricula changes, quality audit etc), total recognition of studies in other Romanian and foreign universities will be assured. The use of foreign languages in the didactic process is highly promoted. There are courses taught in English. Linguistic training for incoming students is provided through an intensive course of Romanian. By the continuous modernization of the laboratories, of the didactic technology and accommodation conditions in the campus, optimal conditions for the activities stipulated in the mobility programmes (didactic, placements, accommodation and food) will be ensured. "Petru Maior" University sets to elaborate a quality control system, which will evaluate continuously the participation to European programmes. All this will be done by respecting the regulations of the Romanian Agency for Ensuring the Quality of Higher Education (ARACIS– www.aracis.ro). This in done inside the University by continuously monitoring these activities, by evaluating students and teaching staff based on questioners, analysis of dialogues and meetings with persons involved in the mobilites. The third cycle of studies will be developed, according to the Bologna organization model. An institutionalized setting for the lifelong learning system will be implemented, thus ensuring the valorization of the knowledge and experience gathered from the academic projects where "Petru Maior" University was a partner.

Quality of student placement activities:

What kind of specific measures are implemented to ensure high quality in student placements? Give details on how the work-programme and the placement agreement are prepared and implemented. Our prior experience enabled us to have the necessary knowledge for making the needed arrangements for the normal development of the mobilities. We have not encountered situations that did not correspond to the standards imposed by the programme. The experience the University has acquired in the Leornardo da Vinci programmes of exchanges and placements provides us with the know-how of the way placements are made in economic, academic and social environments of Romania and the UE partners. Thus, a continual dialogue is maintained with the enterprises and organizations of the economic area, making the cooperation with the business and industrial environment even stronger. The purpose is to raise interest for placements and to create optimal conditions for them. The partners are in communication with one another, to ensure the good development of the mobility. A detailed work-program for days/weeks is done before the actual placement, for all the activities in which the beneficiary will be involved. They will be mentioned in the Placement Agreement. The work-program will be thus conceived and realized so as to be in accordance to the duration of the placement and the objectives of the programme. Students with study mobilities and placements are monitorized through activities of monitoring at their destination by the teaching staff or the staff of European Programs Office. Through the care of the European Programs Office, incoming students have a professior-tutor all throughout their stay at the University, who ensures the monitoring and evaluation of their activities. Incoming students also have a student-tutor, to ensure a better integration in the social and academic environments. An intensive Romanian course is provided for their entire stay at the University. There were no difficulties in the recognition of the studies for the participants in the mobilities, outgoing or incoming. The "Petru Maior" University ensures the full recognition of studies and placements
